

ECS Fees and Payment Details

Fees valid from 1st January 2025

Please note the fees for ECS cards and assessments are increasing from 1st January 2025. Listed below are both the current prices and the prices which take effect from 1st January 2025.

The quickest way to make an ECS application is via the MyECS portal for individuals and via the Employer Portal for companies. Registration and login for both systems can be found on the ECS website at www.ecscard.org.uk

When applying online the system automatically calculates the correct fee and prompts you to pay using a debit or credit card as part of the application process. Employers also have options for BACs transfers and advance credits on account. More information can be found in the Employer Portal guidance document sent out on registration.

ECS Multiple Choice Assessments Fees

The ECS Health Safety and Environmental Assessment and other ECS multiple choice assessments (including Fire, Emergency and Security Systems, Network Infrastructure, Electrical Safety Unit, Building Energy Management Systems) are available via the ECS Remote Invigilation Service (both in MyECS and Employer Portal). Training Providers may also offer these assessments, but pricing with them may differ to coming direct to ECS.
